NOTIFICATION

New Delhi, the 30th June, 2017

No. 56/2017–Customs

G.S.R. 797(E).—WHEREAS the Central Government on being satisfied that the import duty leviable on articles and parts thereof, of goods falling under headings 8443 and 8517 respectively of the First Schedule to the Customs Tariff Act, 1975 (51 of 1975), should be increased and that circumstances exist which render it necessary to take immediate action.

NOW, therefore, in exercise of the power conferred by sub-section (1) of section 8A of said Customs Tariff Act, the Central Government, hereby directs that the First Schedule to the said Customs Tariff Act, shall be amended in the following manner, namely:-

In the First Schedule to the said Customs Tariff Act, in Section XVI, -

- (i) in Chapter 84, against tariff items 8443 32 90, 8443 32 90 51, 8443 99 52, 8443 99 53; and
- (ii) in Chapter 85, against tariff items 8517 12 10, 8517 12 10 51 90, 8517 61 00, 8517 70 90,

for the entry in column (4), the entry "10%" shall be substituted.

2. This notification shall come into force with effect from the 1st day of July, 2017.

No. 57/2017–Customs

G.S.R. 798(E).—In exercise of the powers conferred by sub-section (1) of section 25 of the Customs Act, 1962 (52 of 1962), the Central Government, on being satisfied that it is necessary in the public interest so to do, hereby exempts the goods of the descriptions specified in column (3) of the Table below, as the case may be, and falling within the Chapter, heading, sub-heading or tariff item of the First Schedule to the Customs Tariff Act, 1975 (51 of 1975) as are specified in the corresponding entry in column (2) of the said Table, when imported into India, from so much of the duty of customs leviable thereon under the said First Schedule as is in excess of the amount calculated at the standard rate as specified in the corresponding entry in column (4) of the said Table subject to any conditions, as specified in the Annexure to this notification, the condition number of which is mentioned in the corresponding entry in column (5) of the said Table.
