Before filing the income tax returns it is very important for us to match assessee's TDS details to take correct credit of the same.

Whereas, while going through this process, the Traces site is either very slow and it takes very long to down load or the session is expired.

Taking this into consideration, it will be very difficult and rather impossible to file the income tax returns before the deadline set under the provisions of the Income Tax Act.

In case, the assessee fails to file his/her return before due dates, they are subject to penal action under the new provision of section 271 F of Income Tax Act, 1961.

So, in order to avoid undue pressure and mental tension to the assesseees as well as to the tax consultants/professionals on the last dates, timely action is required on the part of the CBDT at the appropriate time.

It is, therefore, requested to either extend the dates at least in case of business class or update the system so that the e-filing site does not crash at the last moment.
