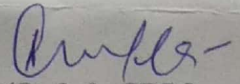
Order Under Section 7(1) of the Right to Information Act 2005

- M/s Infosys is the Managed Service provider (MSP) for the execution of the CPC-ITR 2.0 Project. The company is not given any access to information of Income Tax Payers.

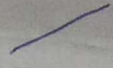
