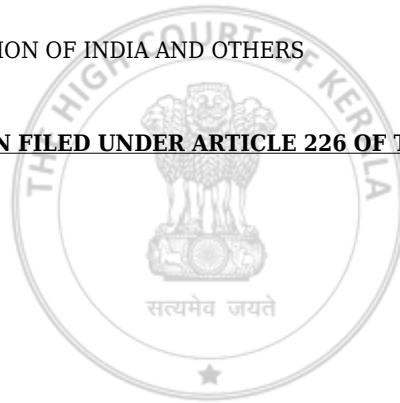

SYNOPSIS

Petitioner is a Limited Liability Partnership incorporated as per the Limited Liability Partnership Act, 2008 on 09/04/2021. In order to increase the total obligation of contribution petitioner LLP resolved to add 83 additional partners to the petitioner LLP by resolution dated 31/03/2022. As per Rule 21(2), 22(2) & 22(3) the same has to be intimated to the Ministry of Corporate Affairs by filing forms 3 & 4 within 30 days of resolution. From March 2022 the forms under LLP Rules have to be filed through Version.3 of the website of MCA. There are several errors in the Version.3 of the website of MCA. Since petitioner company was not able to file form 3 & 4 within 30 days petitioner LLP had raised complaint through its company secretary in the website of MCA and also through e-mail. The respondents are well convinced with the fact that there exists error in the website of MCA. But the respondents have not yet resolved the issue and also not accepting the forms. Petitioner LLP is hence finding difficult even to convince its own investors since the forms are not accepted and also the change is not reflected in the master data

of the LLP in the website. Moreover the penalties for delay in filing forms are increasing day by day due to the fault of the respondents in not curing the defects in the website of MCA. Hence the above writ petition.

DATE AND EVENTS

09/04/2021: Petitioner LLP was registered

March 2022: respondents made mandate that all forms of LLP has to be filed in version 3 of the website of MCA

31/03/2022: Petitioner LLP added new partners and amended its agreement.

**MEMORANDUM OF WRIT PETITION (CIVIL) FILED UNDER
ARTICLE 226 OF THE CONSTITUTION OF INDIA**

The above named petitioner most respectfully submits as follows:-

STATEMENT OF FACTS

1. The petitioner is a Limited Liability Partnership (hereinafter referred as LLP) incorporated as per the Limited Liability Partnership Act, 2008 on 09/04/2021 with LLP IN:AAW-6376 under an LLP agreement dated 20/04/2021. LLP was incorporated with 9 partners with total obligation of contribution 35,00,000/-. A true copy of the master data of the petitioner LLP published in the website of Ministry of Corporate Affairs is produced herewith marked as **Exhibit P-1.**
2. In order to increase the total obligation of contribution, petitioner LLP was searching for additional partners who were willing to invest in the petitioner LLP. 83 partners had informed their willingness to join the petitioner LLP by investing a substantial amount. All those 83 persons had given their consent to act as a partner of petitioner LLP. Since petitioner LLP intends to increase the total obligation of contribution and had received consent from 83 persons to act as partners of the petitioner LLP, the LLP had resolved to admit additional 83 partners by resolution passed in

the meeting of the partners held at its registered office on 31/03/2022. A true copy of the resolution passed in the meeting of the partners of Petitioner LLP on 31/03/2022 is produced herewith marked as **Exhibit P-2.**

3. As decided in P2 resolution the petitioner LLP had amended its limited liability partnership agreement including the names of the 83 persons who had been added to the petitioner LLP. A true copy of the Deed of Adherence dated 31/03/2022 is produced herewith marked as **Exhibit P3.**

4. As per rule 21(2) of Limited Liability Partnership Rules, 2009. (Herein after referred as LLP Rules, 2009) *"For the purposes of sub-section (3) of section 23, every limited liability partnership shall file information with regard to the limited liability partnership agreement referred to in such subsection, in Form 3 with the Registrar within thirty days of the ratification by all the partners alongwith the fee as provided in Annexure 'A'."*

As per Rule 22(2) *"For the purposes of sub-section (2) of section 25, where a person becomes or ceases to be a partner or where there is any change in the name or address of a partner, the limited liability partnership shall file with the Registrar, a notice in Form 4."*

As per Rule 22(3) "for the purposes of sub-section (3) of section 25, in respect of notice of a person becoming a partner, the Form 4 shall include a statement signed by the incoming partner that he consents to become a partner."

5. In order to comply with the above provisions, the petitioner LLP had entrusted a Company Secretary to file form 3 and 4 as prescribed in LLP Rules, 2009.
6. It is most respectfully submitted that the filing of forms through online mode of LLPs are to be uploaded in the new version of the website of Ministry of Corporate Affairs (Version 3) from March 2022. There are several complaints with respect to the errors in filing forms in the website of ministry of corporate affairs through version 3. In version 3 of the website of the ministry of corporate affairs, the forms 3 and 4 are linked together and have to be filed together. Petitioner's company secretary was able to fill form 3 but was not able to save form-4 which is also to be uploaded together since they are integrated forms. Petitioner's company secretary was not able to save the form 4 and error message was shown and the entire entries made in form 3 and 4 was automatically cleared and was not able to proceed to the next page. A true copy of form-3 prepared by the petitioner LLP in the website of the

ministry of Corporate affairs is produced herewith marked as

Exhibit P-4.

7. Since there occurred error in filing forms 3 and 4 of the LLP the company secretary of the petitioner LLP had raised service request in the website of the Ministry of Corporate Affairs and the same was numbered as SR2264550. Even though service request was made in the website the officials had simply closed the request stating that the error screenshot has to be uploaded. A true copy of the email sent by the service desk of the Ministry of Corporate Affairs dated 13/04/2022 is produced herewith marked as **Exhibit**

P-5.

8. After closing the service request petitioner had availed the support of the technical team through telephone and had tried to file the forms as directed by them. Even then the issue was not resolved hence petitioner registered complaint FO_20221107217776 on 09/11/2022 through the website of MCA but the same was closed stating "The reported issue has been resolved. You are requested to try again. If issue still persists, please create a fresh complaint on the portal with relevant details and screen print of the error" A screenshot of the webpage of the MCA showing the complaint is resolved is produced herewith marked as **Exhibit P-6.**

9. Even though the technical support team of the website of Ministry of Corporate affairs contacted the company secretary it was failed to resolve the issue. Hence petitioner had again registered another complaint in the website of MCA as FO_20221119254742 on 09/11/2022 and the same was also closed stating that "You are requested to login in incognito mode, click on submit and you will be able to submit the form." A screenshot of the webpage of the MCA showing the complaint is resolved is produced herewith marked as **Exhibit P-7.** Petitioner tried to upload the same by logging in through incognito mode and even then, the same error was persisting. Hence petitioner registered another complaint on 27/01/2023 as FO_20230124433359 and the same was also stating that "Dear User, Details provided are inadequate to resolve your query. Please share SCREENSHOT. Please enter above information in text only." A screenshot of the webpage of the MCA showing the complaint is resolved is produced herewith marked as **Exhibit P-8.** Petitioner again tried to upload the forms 3 and 4 as said in exhibit P-8 even then the same error is shown in the website of MCA. Hence petitioner again registered another complaint on 04/02/2023 as FO_20230201473575 and the same was also closed by the respondents stating "You are requested to

login in incognito mode, click on submit and you will be able to submit the form." A screenshot of the webpage of the MCA showing the complaint is resolved is produced herewith marked as **Exhibit P-9.** Petitioner tried to upload the same by logging in through incognito mode and even then, the same error was persisting. Hence petitioner registered another complaint as FO_20230207494610 and the same was also closed stating that "the reported issue has been resolved. You are requested to try again in incognito mode" A screenshot of the webpage of the MCA showing the complaint is resolved is produced herewith marked as **Exhibit P-10.**

10. The respondents are closing the complaints raised by the petitioner with copy paste reply and the petitioner LLP was not able to upload form 3 and 4 the annual returns also can not be uploaded in from 11 in the website of MCA. Hence the petitioner had raised to complaint before the 3rd respondent on 12/04/2023 by email. A true copy of the email sent by the company secretary of the petitioner to the 3rd respondent dated 12/04/2023 is produced herewith marked as **Exhibit P-11.**

11. On enquiry it was found that the same issue is there in filing form 3 and 4 for LLP which had increased more number of partners

and the technical team had informed that the in the website the right button of the mouse is not working when more number of partners are increased and they had said that the issue has to be resolved case by case and hence it will take time. But even after registering more than 6 complaints the respondents are not able to resolve the issue and hence the petitioner is not able to file annual return and also, they have not granted any relaxation or extended the time for filing form 3 and 4 without any additional penalty. The errors in the website of MCA are issues faced all over the country. A true copy of an article published in CNBCTV18 dated 21/04/2023 is produced herewith marked as **Exhibit P-12**

12. But even now the petitioner LLP is not able to upload its forms online due to the errors in the website of Ministry of Corporate affairs. The respondents are also well aware of these errors but, they are also not accepting these forms on physical form and also have not extended the time to file the forms online. If the penalty is calculated as mentioned in the Act and Rules the petitioner LLP has to pay a huge amount as penalty for the fault of the respondents in not curing the errors in their website.

13. Petitioner had raised its total obligation of contribution by increasing the number of partners from 7 to 90 as evident from

exhibit P-3, the petitioner is not able to file form 3 and 4 and hence necessary changes are not incorporated in the master data of the LLP. Hence the petitioner LLP was not able to file the annual returns of the year 2021-22 and 2022-23. the due date for filling the annual return for the financial year 2022-23 for the LLP is 30/05/2023. Since the issue is not resolved the petitioner is not able to upload the same also. Moreover petitioner is not able to convince the additional partners who had made contribution to the petitioner LLP since there is no change in the master date of the LLP.

Penalty in delay in filing forms are calculated for each day and the respondents are not taking any steps to resolve the issue and also not extending the time limit for filling forms hence the petitioner has no other alternative efficacious remedy than to approach this Hon'ble Court under Article 226 of the Constitution of India for the following among the other:-

GROUND

- A. The non acceptance of the forms 3 and 4 filed by the petitioner LLP by the respondents is arbitrary and illegal. The respondents are bound to receive the forms in physical form or by email since

there are errors in the website of the Ministry of Corporate Affairs in saving and uploading the forms.

- B. The respondents are well aware that forms 3 and 4 mentioned in the LLP rules are not able to be uploaded in the website of the ministry of corporate affairs and even then, they had failed to resolve the issue or had extended the time for filing the forms without fine.
- C. The penalty for delay in filing forms are calculated day to day basis and if a petitioner LLP is directed to pay the penalty for the errors that had been occurred in the website of the MCA website, the petitioner LLP have to pay a huge amount as penalty for the latches from the side of respondents.
- D. The respondents who are duty bound to resolve the issue but are closing the complaints raised by the petitioner with one and the same reply in a mechanical manner without resolving the issue.
- E. It is the duty of the respondents to resolve a complaint in the website in filing forms within a period of 48 hours. Petitioner LLP had prepared and tried to file form 3 and 4 within 30 days of exhibit P2 resolution and P3 amendment and complaints were registered through the website of ministry of corporate affairs as prescribed under relevant act and rules.

F. The petitioner LLP is not able to convince the investors of the petitioner who had made huge investment as evident from Exhibit P3 LLP agreement, since necessary updation is not made in the master data of the LLP in the website of MCA

For these and other reasons to be submitted at the time of hearing it is humbly prayed that this Hon'ble Court may be pleased:-

PRAYER

- i. To issue a writ of mandamus or any other appropriate writ, order or direction directing the respondents to accept forms 3 and 4 of petitioner LLP through e-mail or in physical form without additional fees.
- ii. To issue a writ of mandamus or any other appropriate writ, order or direction directing the respondents make consequential changes in the master data of the petitioner LLP so as to enable the petitioner to file the annual returns in form 11 for the financial year 2021-22 and 2022 -23 without additional fees.
- iii. To issue a writ of mandamus or any other appropriate writ, order or direction directing the respondents to ensure the proper functioning of Version.3 of MCA portal and give reasonable time for filing form 3&4 without considering the

delay already occurred and not to take any coercive action against the petitioner till then

- iv. To pass any other order or directions this Hon'ble Court deems fit and proper in the facts and circumstances of the case.

INTERIM RELIEF SOUGHT FOR

For the reasons stated in the writ petition and accompanying affidavit, it is prayed that this Hon'ble Court may be pleased to direct the 3rd respondent to receive forms 3&4 by email of petitioner LLP without penalty and direct the respondents to make consequential changes in the website of the MCA so as to enable the petitioner to file annual returns in from 11 without any additional fees pending disposal of the Writ Petition.

A simple scroll on twitter under the hashtag #V3Error will take you to thousands of complaints that company secretaries have raised in the last three months. Every day, these professionals tweet about issues they are facing on the MCA 21 portal marking the helpdesk, MCA and LTI Mindtree, but according to them, all in vain.

There are several complaints about technical glitches on the portal, which are leading to grave issues like not being able to fill important forms, delays in uploading of important documents and delay in downloading certificates of charge registrations. Chartered Accountants (CA) complain that many of these delays are also leading to penalties and are impacting the functioning company secretaries.

Even though, the version two of the MCA21 portal also had some issues, version three has invited more complaints. Complaints started cropping up on social media in January 2023, when more compliance-related filings were moved to V3. 63 more forms were moved to the new version that affected, among others, the start-ups funded by venture capitalists. Because of tech glitches on the portal, company secretaries faced delays in setting up and closing or converting companies or getting DIN numbers.

Earlier in February, Finance minister, Nirmala Sitharaman took note of these complaints and asked for the formation of a special team to address public grievances on a priority basis. As a result, a few helpdesks were set up and a special twitter handle was launched to address the complaints on twitter. However, company secretaries say that the problems are yet to be resolved. In many cases, complaints raised in February remained open for months and were closed without any solution.

"We have filed a LLP Fillip Form for Incorporation on February 28, 2023, which was marked for re-submission on March 5, 2023 reason being, technical glitches, unable to find the form in Doc Tab by V3 Portal. From that date, we have faced multiple issues. The portal was unable to recognize DPIN/ DIN, applicable AO code For PAN/ TAN etc., showing multiple errors, which were accepted during the original submission. For this, we raised a ticket. Further, we faced an issue of expiry of the reserved name of the LLP. For that, we again raised a ticket. Then a fresh ticket dated 06-04-2023 was raised for a new error i.e., DSC validation error. Although DSC was registered with MCA Portal, it still showed DSC validation errors. The previous tickets dated 5th April for the same issue was closed without any solution", said Yash Dhanuka, Proprietor, Dhanuka Yash & Associates.

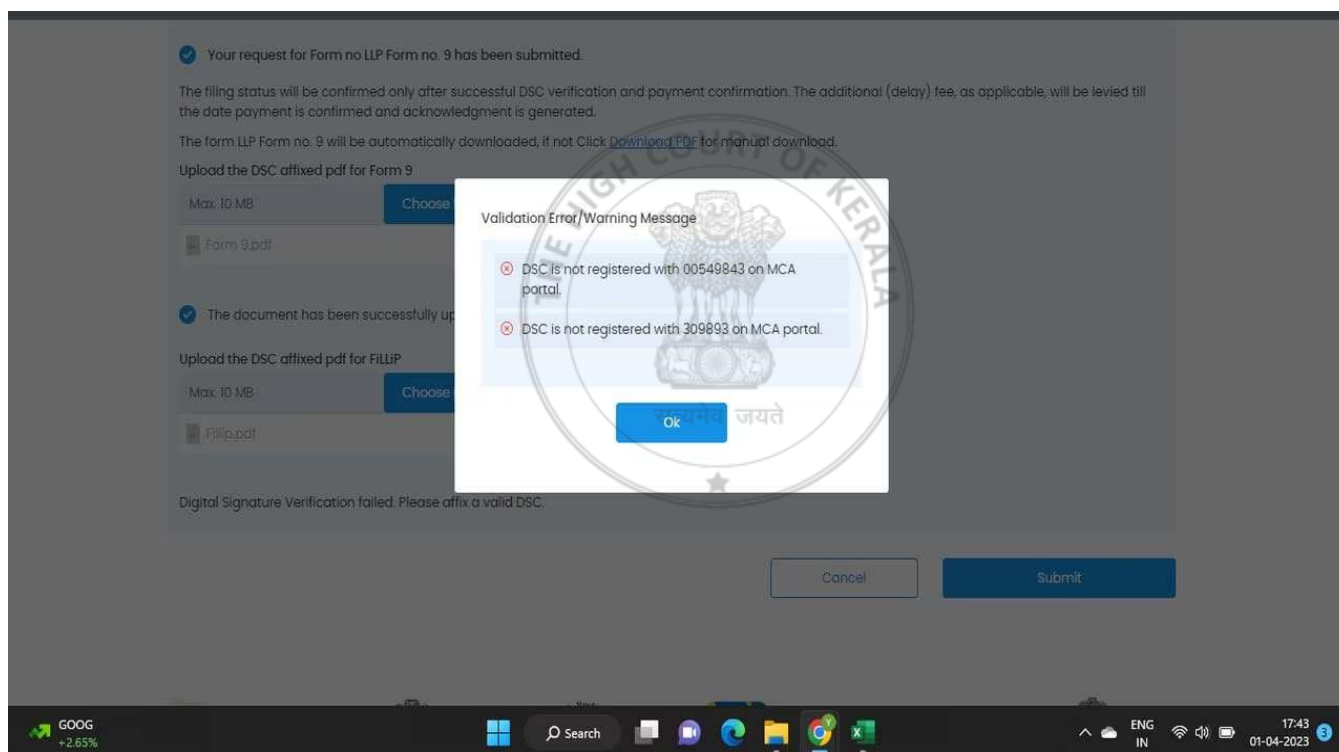
Government view on functioning of MCA 21

Data from the MCA website suggests that record number of filings have happened in the last couple of months. Sources in the Ministry of Corporate Affairs agree that there are technology glitches but they believe these are 'teething issues', which will be resolved soon. They say that the version three was created to fully digitalise and revolutionise the filings on MCA 21 portal. 7 lakh new user registrations have been done in the last two months. The data also suggests that over 3 lakh new DSC registrations have happened in the last two months.

These numbers are important because DSC registrations have been one of the many pain points raised by company secretaries on social media. Sources at MCA say, that many complaints have been coming to them and mostly about the new KYC norms. "Some users just suggest that half of the issues will be resolved if we do away with the KYC norms, but we can't do that. KYC regulations are mandatory to check frauds," said a government source.

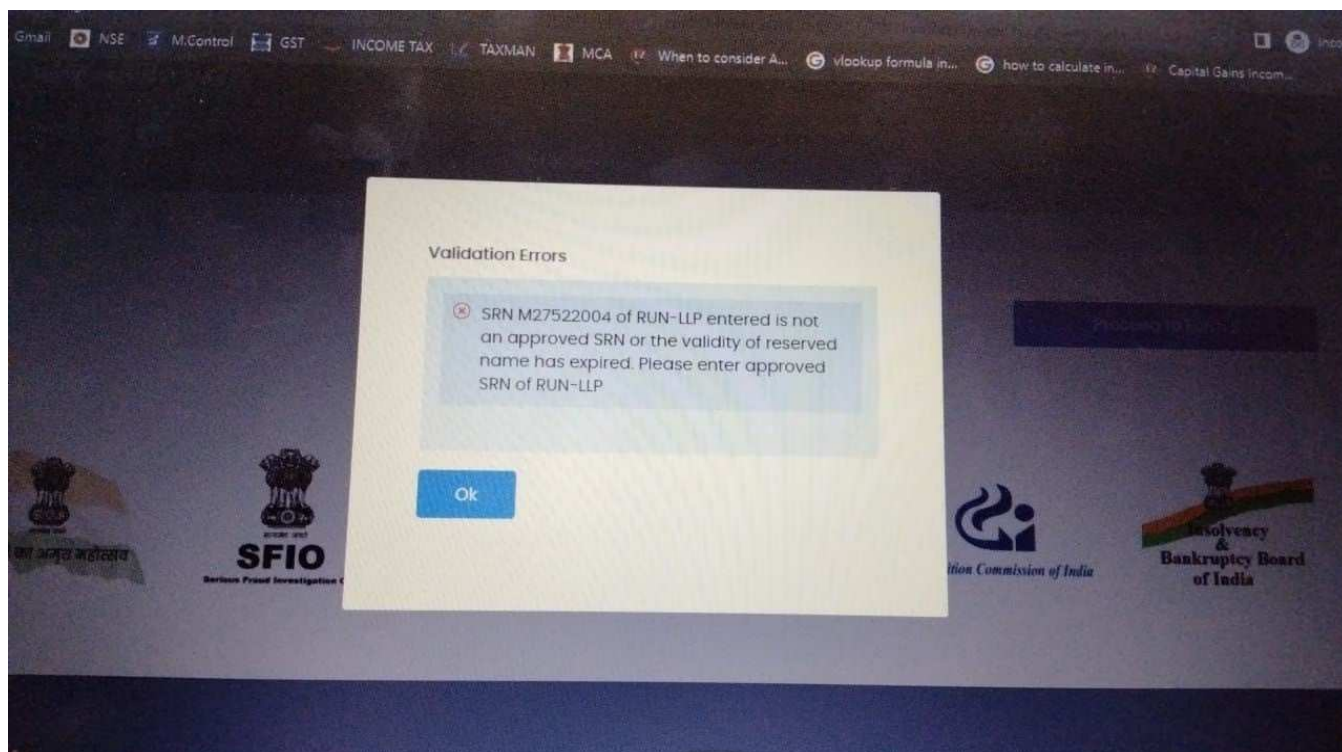
Many professionals are still flagging concerns. "Yes, filings are still being done on the portal. But if it takes 5 hours for a job that used to get done in half an hour, what is the point. I have started waking up at 3am to upload some forms thinking maybe at night, the portal would be smooth because of lower traffic, but it doesn't help", said a company secretary requesting anonymity.



The Indian Institute of Chartered Accountants and Indian Institute of Company Secretaries have been sending representations to the MCA in this regard. These institutions have pushed for extension of deadlines and also demanded waving off penalties in cases where tech glitches have led to delays. However, the extensions can't go on for long.

Aniket Talati, President, ICAI said that there are too many moving parts on the MCA 21 portal and changes lead to initial problems. Talati said that there have been issues whenever portals like these are upgraded.

"We are regularly meeting with MCA about the issues that profess are facing. For understanding of issues that arose from new ways of filing, we are conducting large webinars to educate business users about V3. We have also set up helplines for specific queries. The bigger queries are being shared with the MCA to highlight the challenges", said Talati.



The ministry is planning to move more forms to the version 3 of the portal in coming months. In the absence of a resolution to the existing issues, there could be more complaints in the future. Government officials say that meetings are being held with the LTI Mindtree teams on a regular basis to resolve the glitches on the portal.

CNBC TV18 reached out to LTIMindtree for a comment on the issue, but the company declined to comment.

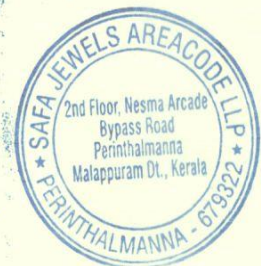
