Corrigendum (Chartered Accountants)

No. 54-EL(1)/12-S-1/2024: In pursuance of sub-rule (1) of rule 6 of the Chartered Accountants (Election to the Council) Rules, 2006 read with sub-regulation (4)(i) of regulation 134 of the Chartered Accountants Regulations, 1988, the List of Voters as on 1.4.2024 for election to the Twenty Sixth Council and Twenty Fifth Regional Councils were published and made available w.e.f. 3rd September, 2024. Pursuant to the publication of the said Lists of Voters, certain clerical mistakes/omissions were brought to the notice of the Institute in respect of List of Voters for Southern India Regional Constituency comprising the States of Andhra Pradesh, Karnataka, Kerala, Tamil Nadu and Telangana and the Union Territories of Lakshadweep and Puducherry. In order to remove the likely hardship to the voters concerned, these clerical mistakes/omissions are now being rectified, after verification of records, in exercise of powers vested under sub-rule (6) of rule 6 of the aforesaid Rules read with sub-regulation (4)(vi) of regulation 134 of the aforesaid Regulations, by way of this Corrigendum.
