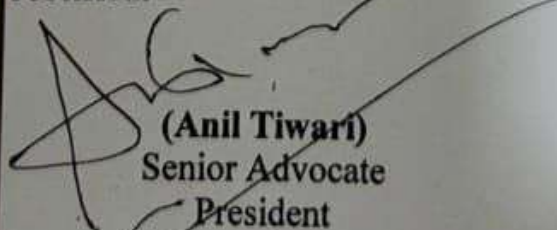
These conducts are creating nuisance of considering as where seen its past.

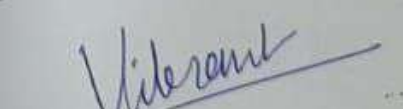

Behavior of some Hon'ble Judges towards the Lawyers and BAR are also not proper rather insulting.

In this regard the President has already informed the Hon'ble Chief Justice and requested his Lordship to intervene but till date nothing appears to have been done and the same situation is still prevailing. Resentment in entire BAR is rising. The Bar is aware about its duty towards the courts of law and is determined to take steps for saving the dignity of this Hon'ble Court and to agitate this matter by taking necessary steps.

Many Hon'ble Judges do not follow the very old tradition of this Hon'ble High Court to revise the list of Fresh cases or of unlisted cases as the case may be.

Your lordship is well aware that now a days the High Court is stretched very far and it has becomes very difficult for many advocates specially the advocates having more than 60 years of age to attend all the courts at the single point of time. Therefore, we demand for restore the tradition of this Hon'ble Court for revising call in all courts practically and not symbolically.

Changing the process of filing and reporting by Hon'ble Judges by passing judicial orders without getting it amended in the High Court Rules and contrary to the Rules.

This tendency leads to a sudden and grave difficulty to be faced by advocates.

In the aforesaid meeting Sri Rajesh Khare (Sr. Vice President), Sarvasri Agnihotri Kumar Tripathi, Akhilesh Kumar Mishra, Subhash Chandra Yadav, Niraj Tripathi, Smt. Nilam Shukla (Vice Presidents) Sumit Kumar Srivastava (Joint Secretary Administration) Abhijeet Kumar Pandey (Joint Secretary Library), Puneet Kumar Shukla (Joint Secretary Press), Ran Vijay Singh (Treasurer), Udisha Tripathi, Abhishek Mishra, Avadhesh Kumar Mishra, Sachchidanand Yadav, Dinesh Yadav, Rajesh Shukla, Sarveshwar Lal Srivastava, Ved Prakash Ojha, Baldev Shukla, Amarnath Tripathi and Brajesh Kumar Singh Sengar (Members of Governing Council) are present.

In view of current situation where even basic demand of High Court Bar Association, Allahabad are being declined by court administration. In this situation, the High Court Bar Association, Allahabad has resolved as detailed below :-

(1) Court conduct of Hon'ble Mr. Justice Rohit Ranjan Agarwal in Court No. 69.

It has already been brought to the notice of Hon'ble The Chief Justice that court conduct of Hon'ble Mr. Justice Rohit Ranjan Agarwal is against the settled procedure and old tradition of this Hon'ble Court. Even the Hon'ble Judge is not following the mandate of Hon'ble Apex Court as laid down in the case of Pradhani Jani Vs. The State of Odisha (Criminal Appeal No. 1503/2023) and Kusha Duruka Vs. The State of Odisha (Criminal Appeal No. 303/2024) and insulting remarks are made against the Lawyers.
