1. Heard learned counsel for petitioner, learned Standing Counsel for the State and Sri Amit Kumar Dwivedi, Advocate, who has filed his Power today on behalf of respondent nos.2 to 5, which is taken on record.

2. Present writ petition is filed by the petitioner for the following main reliefs:

*"I. Issue a writ order or direction in the nature of certiorari quashing the House Tax Bill for the Financial Year 2023-24 pertaining to House No.268/401ka, House ID No.9157A85597, Mohalla, Pole Khera, Ward-Malviya Nagar, Zone-2, Aishbagh, Lucknow received by the petitioner on 29.03.2024, as contained in Annexure No.1 to this writ petition in the interest of justice.*

*II. Issue a writ or direction in the nature of mandamus commanding the Respondent No.2 to 5, to decide the Representation/Objection dated 03.04.2024 U/s-213 of U.P. Municipal Corporation Adhiniyam, 1959 of the petitioner and rectify/amend or alter the House No.268/401ka, House ID No.9157A85597, Mohalla, Pole Khera, Ward-Malviya Nagar, Zone-2, Aishbagh, Lucknow for the Financial Year 2023-24, as contained in Annexure No.2, to this writ petition."*

3. Learned counsel for petitioner submits that petitioner has already moved a representation in this regard on 3.4.2024 under Section 213 of U.P. Municipal Corporation Adhiniyam, 1959. He further submits that grievance of petitioner would be sufficiently met in case representation of petitioner for the said purposes is considered and decided in a time bound manner by respondent no.4.

4. Learned Standing Counsel and learned counsel for respondent nos.2 to 5 have no objection to the same.

5. In view thereof, petitioner is permitted to make a fresh detailed representation to respondent no.4-Zonal Officer, Zone-II, Municipal Corporation, Aishbagh, Lucknow, raising all his grievance, annexing therewith a copy of this writ petition along with annexures and all the documents in support of his claim within a period of one week from today along with a certified copy of this order.

6. In case such a representation is moved by petitioner, respondent no.4 shall consider and decide the same in accordance with law after hearing all parties concerned by a reasoned and speaking order within a period of four weeks from the date, a certified copy of this order along with representation is placed before him. Any demand against the petitioner shall be subject to final order passed by respondent no.4.

7. It is made clear that this court has not applied itself on the merits of the case and all questions are left open to be considered and decided by the competent authority in accordance with law.

8. With the aforesaid directions, present writ petition is ***disposed of***.
