- 3. Regarding the inordinate number of cases being made part heard in RSA MATTERS by a certain judge of Karnataka High court during last roaster session of the High court and the necessity for CHIEF JUSTICE OF KARNATAKA TO DIRECT JUDGES NOT TO MAKE MATTERS PART HEARD.**

5. Regarding the huge corruption in Trial Judiciary and the need to set up proper mechanism to stop it.

6. To request and demand that the Supreme Court of India and the Union of India to establish THE HIGHEST AND RIGOROUS ACCOUNTABILITY STANDARDS FOR HIGHER AND TRIAL JUDICIARY INCLUDING TRIBUNALS BY -

i) Enforcing mechanism for declaration of ASSETS OF JUDGES AND TO MAKE IT PUBLIC.

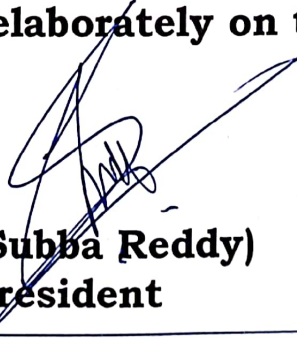
ii) To enforce highest standards of Accountability and to devise a swift mechanism to remove corrupt Judges from the system.

iii) To enforce and clamp the Anti Money Laundering Act against instances of corruption in Judiciary and to freeze such assets under the Act and the same to be supervised by the Apex Court Collegium and to enact a provision to stop judicial work for such Judges till they are exonerated.

7. Regarding the establishment of a transparency trust to stop corruption in Higher and Lower Judiciary as the Apex Court is not doing much to set right the system.
