Subject: Mandatory Minimum Fee Structure for Advocates in India

In exercise of the powers conferred under the Advocates Act, 1961, the Bar Council of India hereby notifies the mandatory minimum fee structure applicable to all practicing advocates across India. This structure shall be followed by all advocates from March 1, 2025. The prescribed minimum fees are fixed, while the maximum fees may vary depending upon the seniority and expertise of the advocate.
