Application for substitution to substitute respondent Nos. 3 to 6 with Asset Care and Reconstruction Enterprise Ltd., as respondent No.3 is allowed.

We have perused the additional affidavit dated 2nd January, 2025 filed by the Director, Ministry of finance, Department of Financial services, New Delhi which records that the substantial number of posts sanctioned to the different Debts Recovery Tribunals (DRTs) in the entire country have been filled in. Therefore, no further directions are necessary.

However, we make it clear that if the respondent-Union of India wants DRTs to furnish data as sought in this case, additional hands be provided by the Union of India so that day to day functioning of the DRTs will not suffer.

With the above observations, the Special Leave Petition is disposed of.
